GSP8 : LNG EXTRACTION WITH CRYOGENIC ETHANE STORAGE & RECEIVE FACILITY PROJECT

PTT Public Company Limited (PTT) intends to build a new LNG Extraction with Cryogenic Ethane Storage & Receive Facility in Maptaput, Rayong Province, to extract essential and valuable elements from the imported LNG meanwhile to increase capacity of ethane distillation to serve the demand of ethane consumption in Thailand. Furthermore, Ethane Storage & Receive Facility to be constructed for increasing capability of ethane storage in order to secure the continuity of the supply ethane to valued customers. The new facility shall be called "GSP8: LNG Extraction with Cryogenic Ethane Storage & Receive Facility Project", abbreviated to "GSP8".

PTT is planning to employ an engineering consultancy services to prepare a Front End Engineering Design (FEED), Site Selection Study for Ethane Storage & Receive Facility and TORs package for bidding EPC Contractor, then support PTT during Bidding, Evaluation and Preparation of Contracts. The period of execution for engineering consultancy services of this contract is approximately 12 months from the Award of Contract Date and the estimated cost is 57,000,000 THB.

PTT invites the interested companies (a single entity) to participate in the bid for Consultancy Services Contract. It is not permissible for the BIDDER to perform the work by forming a joint venture or a consortium, with other companies to collectively qualify for and thereafter execute the work.

The company of Bidders shall prove that they have successfully completed all of following condition with details for their experiences as follows:

Company's mandatory qualifications

Bidder's company must have the following minimum qualifications/ experiences as below:

- a) Registered office in Thailand,
- b) Completed at least one (1) engineering design related to Oil & Gas or Natural Gas Pipeline or LNG or Cryogenic Process or Petrochemical Project over the past 5 years (2017-2021) and the value of such construction contract shall be greater than 500 Million Thai Baht.
 - *Completed project means completion in engineering design includes all stage of engineering design (Front End Engineering Design, Detailed Engineering Design) and accept the work by owner.
- c) Has a company quality management system and certification for ISO 9001 Quality System.
- d) Bidder shall not be the company or group of companies who has potential to use product's technical and commercial information including pricing structure, product cost, or investment budget to do business with PTT.
 - *Company or group of companies shall include direct and/or indirect subsidiaries, associated companies and/or affiliated companies.
