**PTT Public Company Limited (PTT)** and subsidiaries in PTT Group intend to study on Carbon Capture and Storage (CCS) Hub Model in Eastern Thailand maximum 9.5 MTPA of CO<sub>2</sub> collected from industrial plants in Rayong and Chonburi provinces to the onshore terminal which will be located somewhere in Eastern Thailand, including study on a new CO<sub>2</sub> Transmission Pipeline and the onshore terminal design configuration and location.

PTT is planning to engage a Consultant to carry out engineering consultancy services for feasibility study, site selection study, and preliminary design for CO<sub>2</sub> Transportation and Onshore Terminal including CO<sub>2</sub> value chain integration for Carbon Capture and Storage (CCS) Project. The scope of services are as follows:

- TASK 3: CAPEX and OPEX Estimation for Onshore Pipeline and Terminal
