PTT Public Company Limited (PTT) intends to award the EPC Contractor for the Bangpakong – South Bangkok Power Plant Transmission Pipeline Project Phase 2 (BSPP2). The successful Bidder who will be responsible for the engineering, procurement, construction, commissioning, and related services as described in the Bid Documents. The BSPP2 project comprises of a 36 inch diameter underground main natural gas pipeline which is approximately 23 kilometers in length (commencing from the termination point of BSPP1 in Bang Plee, Samut Prakan Province to the existing Metering and Regulating Station of the South Bangkok Power Plant (SBMR)), future gas sale tap valves, block valve stations and associated facilities. The project period is approximately 36 months from the Award of Contract Date to the Completion Date. The estimated total cost is 2,888,565,337 THB.

PTT would like to invite an interested juristic person, Single Entity or Joint Venture, to bid on equal terms. Bidders shall be the same person(s) who purchased/received the Bid Document and shall not assign the right to bid to the others. In case of Bidders being a Joint Venture, the mentioned Purchaser/Receiver must be a party of the said Joint Venture. The Joint Venture shall be the same person as the purchaser of the Bid Documents and any member in the said Joint Venture is prohibited from transferring his rights to others to submit the Bid in his place. Otherwise, the Bid will be rejected on the submission date as non-responsive.

The Bidders shall demonstrate references with details that they have successfully completed all of following condition for their experiences since year 2011 as follows:

- At least one (1) completed Project as an EPC Contractor for oil & gas or petrochemical pipeline or facility projects, each of which has a lump sum contract value greater than 50 Million USD.
- At least one (1) completed Project as an EPC Contractor for oil & gas or petrochemical pipeline projects, each of which has diameter 36" or larger with length a minimum of 20 kilometers.
- At least one (1) completed construction for oil & gas or petrochemical project(s) at existing facilities in Thailand.
